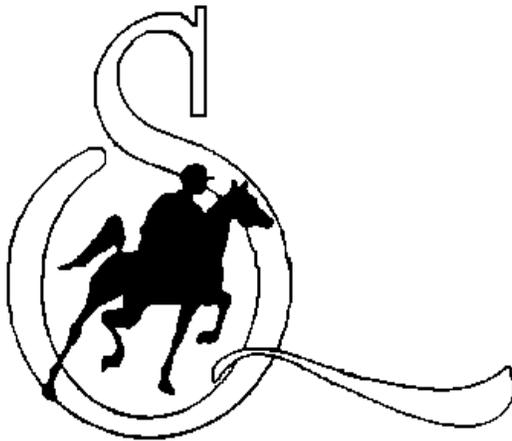

**Trails**—Lori attended a Santa Clara County Park Public Workshop Steering Committee Meeting. She reported that no new trails are planned for Calero Park. The new acquisition adjacent to the park is still in escrow and should be closing soon. When the purchase is complete, part of the trails on the property will be available for use.

The new Bear Ranch-Coyote Lake Park was discussed; opening trails will be the first priority of the plan when funds become available.

There will be a meeting on April 28 regarding dams in Coe State Park. *NOTE: that meeting has been postponed until June, no date yet, will put it on the QSER website.*

**Ride**—The State Fish and Game Department have agreed to the use of the Stevenson Ranch as the staging area for the Spring Ride. Discussion about ride entry fees resulted in the decision to charge \$100.00 for the 50 mile ride and \$90.00 for the 25. Entries must be postmarked by May 10, 2003.

There will be no poker ride or midnight ride this year.

Don't forget to check out the third annual Western States Horse Summit being held in conjunction with the Western States Horse Expo, May 30-June 1 at the Cal Expo in Sacramento.

There will be continuous speakers and exhibits on all three days from 10:00 AM-5:00 PM. The entry fee to the Expo includes attendance at the Summit.

The purpose of the Western States Horse Summit is to inform, educate and distribute research data and information to ensure the continued use and expansion of multi-use trails by equestrians.

On Friday morning there will be a panel of representatives from our National, State, County and Local Parks. The main topic is

**"Will our parks be closed during the fire season?" The speakers will also update us on trail closures and any new park rule changes.**

*This panel will provide an excellent opportunity for frequent trail users like ourselves to learn about their concerns and to give some input—hope to see some of you there!*

Saturday and Sunday mornings there will be a panel of National, State and local horse organizations discussing current problems facing the equestrian industry. Friday, Saturday and Sunday afternoons there will be presentations on "Environmental Aspects of Horses on Trails", "Horse Camping", "Water Quality and Horse Management", and "Getting You and Your Horse Ready for the Trails."

West Nile Virus Symptoms

*I have attended several meetings at which veterinarians spoke about WNV but didn't really get a clear picture of the all of symptoms until I read an article the Western Times by Bonny Davis. Here a few new-to-me ones.*

**WNV Symptoms from a report by Dr. Robert J. McKay, University of Florida.**

**Muzzle Tremors**—the muzzle will twitch sometimes for hours or days. There will be no

apparent reason, no flies. Just a constant twitch with or without a temperature.

**Changed Behavior**—depression is common. Hyper-responsiveness such as flinging around a stall, anxiousness and sweating may occur.

**Tongue Paralysis**—the tongue may lop out and the horse can't get it back in.

Not many people know that I ever owned a second horse. Everyone knew about Pistol. And Pistol was my soul mate. Kate was... well, it is hard to describe the relationship that Kate and I had. She allowed me to take care of her. That was as good as it ever got. Kate and I never bonded. I wanted to bond with her but at best our relationship was one of putting up with each other. And a lot of the time we were totally annoyed with each other.

She was a good horse and well trained as long as all you wanted to do was go around an arena. I took some classes on her and found out that she was well trained and smart. She was a beautiful horse, half Arab and half Tennessee Walker. She was the smoothest horse I've ever ridden. However I like to trail ride and was not reliable on the trail. In fact unless I was riding with someone else so she had horse company I couldn't even get her out on the trail.

I knew Kate could bond. I had seen her with her previous owner who had raised her from a tiny foal. When her previous owner brought her to the ranch and left her after a tearful goodbye Kate was beside herself. Nothing consoled her and she was a handful to work with. I had her in a paddock so she and I could get used to each other. I didn't want to chase her down in the pasture. When that didn't work I decided to turn her loose in the same pasture I had Pistol in with him and several other horses.

I was worried since as far as I knew she had never been in a large pasture with other horses before. She took to the situation immediately and within minutes she had rounded up the mares into a group and proceeded to defend them against the geldings. Whereas before the mares and geldings formed one herd, now there were two herds with Kate running the show.

Kate did seem happier after she was turned out in the pasture. She was calmer when I worked with her. But for the entire time I owned her she remained aloof to me and her behavior was that of a wild, impossible child. Within a few months of buying her I wanted to sell her. Yet somehow I never got to the point of actually doing it. It was always "next month I am selling this horse", but next month never came. Why I don't know. 
